The meeting was called to order by Chair Mike Leclair at 7:00.

Public Hearing

M/M/S Leclair/Fletcher to open the public hearing at 7:07

Derek from USS Maple Solar opened the discussion with an overview of the site plan.

- CMP has completed their cluster study. The site has been downsized from two previous plans from a 5megawatt system down to less than 1megawatt. The site was to include 30-40 acres, it is now 7.4 acres.
- Fence posts will be pine.
- · A knox box will be on site.
- A berm will be in place to help reduce the noise from the equipment.
- Spruce trees will be planted at a maximum height of 6 feet. USS Maple Solar will be responsible for the trimming of the trees and the care of the panels.
- There will not be any overnight lights.
- Hire local contractors to maintain the array.
- · Will be plowed in the winter
- Are there alarms in case of fire? No alarms will sound. The array will be monitored remotely and if a loss in production is recognized they will trouble shoot.
- Breaking ground this fall. Will take 6-7 months to complete.
- CMP will turn on the array in late summer of 2026.
- This array has a 20 year lease. They will have 12 months to remove all the equipment and turn the ground back to its original state once the array is decommissioned.
- Conrad Heeschen, an abutter of the array, commented that the tree buffer is too close to the fence.
