Bids will be reviewed by the Town Manager and Board of Selectmen at their regular meeting on **TUESDAY, SEPTEMBER 2, 2025 at 6:00 PM.** The Town of Wilton reserves the right to hold the proposals for a period of 7 days from the submission date without taking any action thereon to allow for inspection/testing of proposed equipment prior to making a final decision on proposal acceptance.

Final award of bid is contingent upon Selectboard decision.
