Item # 1- Pledge of Allegiance

Item #2- Minutes from September 16, 2025, Select Board Meeting

Item #4- Robert Rogers- Donation of Wilson Stream Dam Gauge

Robert Rogers shared a graphic of the dam at the lake. He would like to replace the current gauge with a newer one that is calibrated in tenths of a foot and not in inches. He is working on his master's degree from UMO. He would like to record the lake level as part of his thesis. It would be beneficial to the town for him to replace the gauge. It would require him to drill a couple of holes into the dam to hold the gauge. There would be no cost to the town, any expenses will be bundled into his student expenses. He is looking at doing this for next summer (2026). He does have liability insurance. Rob has spoken with Nels about this. This would be considered a donation to the town.

Item #5- Jim Lord- Dirigo Engineers- Update on Water Transmission Line Project

Jim Lord came to provide an update to the town on the water transmission line project. Jim gave an update on what has been completed so far through the project, how things are going, and how they will progress through the fall/winter months.

Project was bid on March 11, 2025, the project was awarded to Pratt & Sons, Inc with contracts signed on April 8, 2025. Construction began in April 2025 on Weld Rd near Doak St. As of September 26, 2025, the contractor has completed items such as:

- installation of approximately 9000 feet of water main along Weld, Colby Miller & Orchard Rd.
- testing of approximately 8000 feet of water main along Weld, Colby Miller and Orchard Rd (still need to test 1000 feet on Orchard Rd)
- New water main on Weld Road is active
- installation of approximately 2800 feet of water main along the utility corridor
- testing of approximately 2800 feet of water main on North Pond Rd to the Water Treatment Plant
- installation of several valves, hydrants, and appurtenances, placement of over 1000 tons of pavement, removal of 1083 cubic yards of ledge
- 15 water services along Weld Rd complete and on new water main
- As of 9/26/25 contractor has earned \$2,888,408 of the contract amount of \$7,773,800 which represents approximately 37% complete

Anticipated schedule for the remainder of 2025: complete Orchard Rd and N. Pond Rd water mains, complete cleanup, paving, testing, and disinfection, constructing a temporary connection at Doak St and at the crossing on Colby Miller Rd so the cross country run from Colby Miller to Doak can be abandoned.

Anticipated schedule for 2026: install new pumps at the water treatment plant during the winter, complete the Doak St control valve building, complete the raw water pipeline, complete the new intake, necessary piping and services in the Applegate neighborhood, demo of the Applegate booster pump station, connect all services to the new main along Orchard and N. Pond Rd, and cleanup.

Item #6- Woodland Wanderers Snowmobile Club- Eric Brown- Snowmobile Grant

WWSC is requesting approval for applying for Municipal Grant for the area trail system. The budget is \$24,200. The grant is received every year. It is reimbursement for maintaining the trails, putting up signs, repairing bridges, grooming, etc. Eric Brown keeps track of the work and the reimbursement needed. There is no real work required from the town except to sign the form.

Motion by Keith/ Second by Phil – To approve the WW to apply for the Municipal Snowmobile Grant through the state and to authorize the Town Manager to sign.

Item #7- Municipal Quit Claim Deed- Map 18 Lot 014.

A title company approached the town requesting the approval of the Quit Claim due to discharges not being filed. This dates back to 2013-2016. It has been paid off.

Election Updates: Election Day is scheduled for November 4th from 8:00 AM- 8:00 PM for the Referendum Election. Absentee Ballots are available. Registered voters can fill out an absentee ballot application, and ballots can either be picked up or mailed to you. The deadline for requesting an absentee ballot, except in certain emergency situations is by close of business Thursday, October 30th, which is 5:00 PM. Voters may come into the Town Office to register to vote with proof of ID & residency or may do so at the polls on voting day. The Selectboard

Over the next year, John E. O'Donnell & Associates will be conducting a re-evaluation program for the Town of Wilton.
