Invitation to Bid – 2026 or 2027 Ford Police Interceptor Equipment Package

The Town of Wilton is soliciting sealed bids from qualified emergency vehicle upfit vendors to furnish, install, test, and deliver a complete police vehicle equipment package for one (1) 2026 or 2027 Ford Police Interceptor Utility AWD patrol vehicle. Attached specifications identify the minimum acceptable equipment and installation requirements. More specifically Emergency vehicle lighting and siren system, console and mounts, push bumper, weapons management, prisoner transport, rear cargo storage, radio parts, tint, miscellaneous additions, and install labor. Vendors may propose equivalent products; however, all substitutions must be clearly identified and accompanied by manufacturer specifications.

Attached is the Bid Specifications Sheet outlining the required equipment and options. For any equivalent items, clearly identify the manufacturer, model number, and description on the provided line or a separate sheet. Mark unavailable items as “N/A,” include relevant brochures and product literature, and clearly identify any deviations, substitutions, or changes from the specified requirements with your bid submission.

Interested dealers are invited to submit a sealed bid in accordance with the specifications provided herein and in the accompanying specification sheet.

Bids will be opened at 12:00 PM. on September 23, 2026. Bids will be reviewed by the Town Manager and the Selectboard at their regular meeting on **TUESDAY, October 6, 2026 at 6:00 PM.** The Town of Wilton reserves the right to hold the proposals for a period of 7 days from the review date by selectboard without taking any action thereon to allow for inspection/testing of proposed equipment prior to making a final decision on proposal acceptance.

Final award of bid is contingent upon Selectboard decision.
